- **Alcoholic beverages are not permitted.**
- **CANCELLATION:** Should you decide to cancel your reservation, the amount received is refundable upon written request to the Park Board for their approval, a minimum of fourteen (14) calendar days prior to your rental date. No rain checks or refunds will be given due to bad weather or late cancellations.

By acceptance of this agreement, the group and its participants agree to see that all necessary safety precautions are followed and will indemnify the Village of Warsaw, it's employees and agents, and save them harmless from and against any and all claims damages, liability and expenses in connection with loss of life, personal injury, and or damage to property arising from or out of any occurrence arising from the exercise of the privileges granted in this agreement. This agreement is not binding until approved and signed by the RiverView Community Park Board or a designated authorized agent.
