The sewer grinder that the Village will be leasing through Farm Credit Lease/Co-bank has been completed and the paperwork has all been submitted. The second lease for backup sewer grinder will be installed the first of March and the paperwork will be getting signed and set up with Farm Credit Lease/Co-Bank.

The Village will submit a \$10,000.00 deposit on each project from the American Rescue Fund for the first lease payment. These lease's will be set up for a 72 month in the following amounts; Lease #1 2022 Custom Channel Grinder and Pump Station \$51,361.00 Lease #2 2022 Godwin Dri-Prime NC 80 Pump w/piping \$63,624.00

The Village will be opening up sealed bids for the Lead Service Line Project on February 24, 2022 at 1:00PM. The bids have been advertised in The Coshocton Beacon February 10th and 17th, 2022. Ronny Portz will be attending and opening up the bids and then make his recommendation for the council to approve. This project will be paid from the OEPA WSRLA forgiveness loan.

security system.
